**Topic: Vote to Approve the Town Wide Mask Mandate**

**Discussion:** The Board discussed a mask mandate for the Town of Southborough. Ms. Sacco and Dr. Medina agree that it is a must in Southborough. Surrounding towns have mask mandates and it might help to curb the spread. Dr. Alker stated the Omicron variant is more contagious and she would vote yes. Ms. West agreed and feels it needs reinforcement. Chief Paulhus would like to leave the reinforcement up to the Board of Health. He stated the police would respond to private businesses and would provide education. Ms. Malinowski prepared a draft based on surrounding towns. She would like to ask Town Counsel to look at the document. Information will be posted on the Town's website, social media, distribution through EDC to businesses, board at Transfer Station, etc. The Board's goal is to make it effective Thursday, January 13<sup>th</sup> at 12:01 AM.

**Action:** Ms. Malinowski made a motion to adopt an emergency mask mandate (which will be revisited at the Board of Health February 8<sup>th</sup> meeting) subject to any minor changes that Town Counsel may make. Ms. Sacco seconded the motion. Vote to approve the meeting minutes: Ms. Malinowski – yes, Ms. Sacco – yes, and Dr. Medina – yes.
