Item 1: Election for Committee Chairman

Motion: Al Hamilton made another motion to appoint Peter Goodney Chairman of the Committee.

Motion was seconded by Mike Moorhead. The Committee had discussion. Both motions were withdrawn by Al Hamilton.

Motion: John Wood made a motion to nominate Jason Malinowski Chairman and Peter Goodney Vice Chairman of the Public Safety Committee. Jason Malinowski seconded the motion. The Committee voted UNANIMOUSLY.

Item 2: The Committee Discussed the Public Safety Presentation

- Al Hamilton proposed that the Committee be on record that if it is the will of the Town to preserve the Golf Course the Committee will do its utmost to facilitate. As long as the design of the Public Safety Building is not compromised.

Motion: Al Hamilton made a motion to accept the above statement from the Committee. John Wood seconded the motion. The Committee voted UNANIMOUSLY.
