The Board opened the public hearing in the Public Meeting Room of Southborough Town Hall on November 28, 2018 at 7:15 with regard to the petition for the appellants for the following:

Procedural History:

1. An application for a Special Permit was filed in the Office of Southborough Building Department on October 31, 2018.
2. The application for a special permit to open a medical office practice specializing in aesthetic and cosmetic medicine.
3. The applicant is seeking a special permit from sec. 174-8 C (2) "The board of appeals may, by special permit, allow several different uses if otherwise permitted in district".

4. The record owner of the subject property is Hester, Mei-Ling Cheng Trustee, Strawberry Hill Realty Trust, Southborough, MA. 01772.
5. A public hearing before the Zoning Board of Appeals was duly noticed in the Metro West newspaper on both Wednesday, November 14, 2018 and November 21, 2018.
6. Public Hearing opened on November 28, 2018 and closed on the same evening.

Plans / Documents:

1. GIS, Maps Online of 60 Central Street.
2. Color photos of the existing front and rear views of the building.
3. Letter from the Building Commissioner / Zoning Enforcement Officer Mark Robidoux to Mr. Terigi Ciccone, dated October 31, 2018.
4. Certified assessors abutters list dated October 24, 2018.

Findings:

1. The proposal constitutes a special permit request under the Town of Southborough Zoning Bylaw.
2. The property is located in the (BV) Business Village Zoning district.
3. The proposal and evidence presented meets the criteria required to grant the relief for the special permit requested.
4. Existing business, a hair salon, located on the first floor with 19 available parking spots.
5. Multiple uses are permissible for this zoning district. The multiple uses intended here, a hair salon and medical office practice specializing in aesthetic and cosmetic medicine, are complementary to each other and in harmony with the existing neighborhood on Central Street.

Decision and Vote of the Board:

At its meeting on November 28, 2018, the Zoning Board of Appeals voted unanimously (5-0), to grant the special permit pursuant to Sec. 174-8 C (2) "The Board of Appeals may, by special permit, allow several different uses of otherwise permitted in district."

After review of all evidence and facts presented at this hearing, and after deliberations on the same, voted unanimously (5-0) on a motion made by Mr. Dennington, and seconded by Mr. Drepanos, with member voting as follows to grant the requested Special Permit:
