SPECIAL SPEED REGULATION NO. 7505

Highway Location: SOUTHBOROUGH
Authority In Control: TOWN OF SOUTHBOROUGH
Name of Highway: OAK HILL ROAD

In accordance with the provisions of Chapter 90, Section 18, of the General Laws (Ter. Ed.) as amended, the following Special Speed Regulation is

hereby Adopted
by the Board of Selectmen
of the Town of Southborough

That the following speed limits are established at which motor vehicles may be operated in the areas described:

OAK HILL ROAD - NORTHBOUND

Beginning at the Ashland Town Line
Thence northerly 0.47 miles at 35 miles per hour
0.20 " " 30 " " " ending at the
junction of Route 9; the total distance being 0.67 miles.

OAK HILL ROAD - SOUTHBOUND

Beginning at the junction of Route 9
Thence southerly 0.20 miles at 30 miles per hour
0.47 " " 35 " " " ending at the
Ashland Town Line; the total distance being 0.67 miles.

Operation of a motor vehicle at a rate of speed in excess of these limits shall be prima facie evidence that such speed is greater than is reasonable and proper.

The provisions of this regulation shall not, however, abrogate in any sense Chapter 90, Section 14, of the General Laws (Ter. Ed).
