President's Letter by Jennifer Gonzalez, Holbrook Finance Committee

The Commonwealth's FY 15 budget was signed by Governor Patrick on July 11<sup>th</sup>. Unrestricted General Government Aid and Chapter 70 School Aid increased by an aggregate \$125 million over FY 2014 as stated in the Legislature's Local Aid Resolution in March. <http://www.mma.org/local-aid-and-finance/13529-fy15-budget-signed-without-local-aid-vetoos>

On May 30<sup>th</sup>, a supplemental spending bill for fiscal year 2014 was passed. It included fully funding the partial reimbursement of charter school tuition costs deducted from the Cherry Sheets under the Ch. 70 line item. <http://www.mma.org/local-aid-and-finance/13353-supplemental-budget-with-27-6m-in-charter-school-funds-signed-into-law>

ATFC dues also supports representation on the MMA Board of Directors, policy committees, and the Local Government Advisory Commission, a monthly meeting of local officials with the Governor, Administration staff, or Legislators.
