Structural fire fighters' protective clothing (PPE) is designed to protect members from the thermal environments experienced during fire fighting as well as from chemicals, bloodborne exposure and incidents that cause soft tissue injuries. NFPA 1971 Standard on Protective Ensembles for Structural Fire Fighting and Proximity Fire Fighting requires replacement of PPE at 10 years.
